CLERK'S REPORT/PRESENTATIONS

- CHERYL BOUDREAU REPORTED THAT THERE WERE 51 WORK ORDERS FOR MONTH OF JANUARY, 20 OF THEM WERE MISCELLANEOUS (LEAKS ETC.), 14 WERE CONNECT WATER AND 17 WERE DISCONNECT.

POLICE COVERAGE FOR MONTH OF JANUARY TRANSPIRED –101/TRAFFIC STOPS – 80/CONTACTS – 51/CALLS FOR SERVICE AND 15/ARREST. ALSO ATTACHED YEAR END REPORT FOR 2020, THAT SHOWS THE EXTRA DUTY OFFICERS HIRED BY PELZER, AND IF YOU LOOK AT THAT REPORT THIS EXTRA DUTY IS MAKING A BIG DIFFERENCE FOR OUR TOWN.

OLD BUSINESS –

- A. SURVEY FOR MONKEY PARK – MAYOR RAGLAND STATED THAT WE ONLY RECEIVED 2 BIDS, AND THE ONE FROM RIDGEWATER FOR \$3,950.00 WAS THE LOWEST, MADE THE MOTION TO ACCEPT THIS BID, EDDIE WAITS 2ND THE MOTION, ALL IN FAVOR. APPROVED
- B. TOWN HALL LOBBY RENOVATIONS – MAYOR RAGLAND STATED WE ONLY RECEIVED 1 BID FOR THIS, MAYOR MADE THE MOTION TO APPROVE THE BID RECEIVED FROM CHRIS BAKER, ALISHA TUTTLE 2ND THE MOTION. MIKE MATHEWS STATED THAT HE WOULD RATHER SPEND THAT MONEY IN THE HOSPITAL AND NOT THE CURRENT TOWN HALL LOBBY. MOTION WAS APPROVE BY MAYOR RAGLAND, SKIP GOLDSMITH, EDDIE WAITS, & ALISHA TUTTLE VOTED TO APPROVE THIS MOTION. MIKE MATHEW OPPOSED. MOTION PASSED WITH A 4 TO 1 VOTE.
