CALL TO ORDER – 7:00 – MAYOR ROGER SCOTT, SR.

APPROVAL OF MINUTES FOR NOVEMBER 13, 2018 COUNCIL MEETING MIKE MATHEWS MADE MOTION TO ACCEPT, GARY PRIDMORE SECOND THE MOTION, ALL IN FAVOR.

- CITIZEN INPUT –
- EARL – QUESTIONED MAYOR AND COUNCIL WHY THEY GAVE MILL TOWN PLAYERS MONEY FOR A SIGN, WHEN THEY MAKE MONEY AND DO NOT CONTRIBUTE TO THE TOWN. “IF THE TOWN HAS MONEY THEN THEY CAN GO DOWN ON HIS WATER BILL.” MAYOR SCOTT STATED THAT HE APPRECIATED HIS OPINION, BUT MAYOR AND COUNCIL THINK IT IS A GOOD IDEA TO SUPPORT OUR LOCAL THEATHRE.
- TERRY DAVIS – ASKED IF MONEY THAT WAS CONTRIBUTED WAS FROM HOSPITALITY TAX? MAYOR SCOTT ADVISED HIM THAT IT WAS, MR. DAVIS THEN STATED THAT THE MONEY IN THE HOSPITALITY TAX ACCOUNT CAN ONLY BE USED FOR SUCH ITEMS, MAYOR SCOTT CONFIRMED SUCH.
- LINDA FORD MADE MENTION OF A RESIDENT IN HER AREA SITTING IN HIS DRIVEWAY SHOOTING A GUN IN THE AIR, AND THAT WE NEED TO START WORKING ON ORDINANCES FOR SUCH THINGS. MAYOR AND COUNCIL WHOLE HEARTLY AGREED TO THAT AND STATED THAT THEY WILL BE WORKING ON MORE ORDINANCES IN THE UPCOMING YEAR AND THAT IS AT TOP OF LIST.
- TERRY DAVIS ASKED IF MAYOR AND COUNCIL WERE GOING TO PUT TOGETHER A LIST OF ITEMS TO ACCOMPLISH FOR 2019. MAYOR SCOTT STATED THAT WAS A GOOD IDEA AND THAT THEY COULD DO THAT.

MAYOR ADVISED THAT TOWN CLERK, CHERYL BOUDREAU IS IN CHARGE AND HAS BEEN SINCE JANUARY 2018, IF ANYONE WANTS TO RENT THE BUILDING, THEY NEED TO CALL OFFICE AND SPEAK WITH HER.
- GARY PRIDMORE MADE MOTION TO GO INTO EXECUTIVE SESSION, MIKE MATHEWS 2<sup>ND</sup> MOTION, ALL IN FAVOR.
